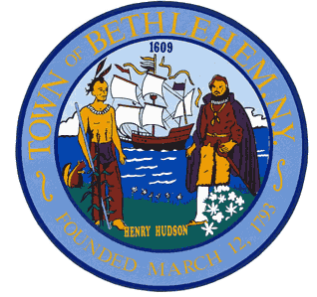

II. Public Hearings

A. Comfort Inn-37 Route 9W, Glenmont for Area Variance(s) under Article VI, Section 128-59, G. Signs and 128-59, K (18-01000018)

The Applicant is proposing to remove and replace two freestanding signs, the first sign is located at the front of the property with the second at the rear of the property that overlooks the New York State Thruway. The applicant is requesting variances for height, overall size, setback requirements and an additional sign as only one freestanding sign is permitted.

The property is located in the Commercial District and is currently a hotel.

Ricky Narang spoke on behalf of Comfort Inn, 37 Route 9W, Glenmont. He expressed the need for larger signage so the Comfort Inn signs can easily be seen by motorist traveling on the New York State Thruway and on US- Route 9W in Glenmont. The following issues were discussed:

Safety concerns for motorist who pass the hotel due to poor signage and need to turn around on the busy interstate.

- Signage by nearby business's
- Reasoning for two signs
- Hours the sign is illuminated

- Description of proposed signage

Craig and Doris Jensen live at 22 Old Route 9W they had concerns regarding the size of sign and lighting on the site

There was no one present to speak in favor or in opposition of the variance.

The Board requested the Applicant provide the following:

1. A rendering of a sign in conformance
2. A rendering from the bridge on Route 9W facing south showing height of current sign vs signage proposed.

The Board voted to table the Public Hearing to give the Applicant time to submit the requested material and have ACPB weight in.
